



Golfmax Rebate Eligibility Requirements Terms and Conditions

- a. The NGCOA Canada Member Golfmax benefit is a 1.5% rebate of the purchase price of Rain Bird golf irrigation products when purchased from a Canadian Authorized Rain Bird Golf Distributor or a Golf Contractor who purchased from a Canadian Authorized Rain Bird Golf Distributor.
- b. A rebate claim will not be processed or approved by Rain Bird unless it includes the following:
 - i. Rain Bird's online Golfmax Claim Submission Form
 - ii. A complete and accurate copy of the member purchase invoice corresponding to the rebate claim, which invoice must be from a Canadian Authorized Rain Bird Golf Distributor or a Contractor who purchased from a Canadian Authorized Rain Bird Golf Distributor.
 1. The following details must be clear on the submitted purchase invoice:
 - a. the Rain Bird Part Number, Item ID, or SKU if available;
 - b. a description of the product purchased with enough information to allow identification of the product purchased;
 - c. the quantity of each product purchased;
 - d. the date of purchase;
 - e. the unit price paid by the golf course to the Rain Bird Distributor or Contractor for each individual product and the unit price must exclude tax, labour, and other ancillary (non-product) costs;
 - f. Tax, labour and other ancillary (non-product) costs are excluded from the rebate.
 2. Failure to provide the required information may result in the forfeiture of the requested rebate.
 - iii. The name of the irrigation consultant involved in the project, if applicable.
- c. "Rain Bird Golf Products" or "Golf Products" shall mean the golf products that are eligible for a Golfmax Rebate. The Rain Bird Golf Products shall only include the products included in the following categories, as identified in the Rain Bird Golf Catalog located on the Rain Bird website at www.rainbird.com/golf/support:

- i. Central Control Systems
 - ii. Field Control
 - iii. Golf Rotor and Swing Joints
 - iv. Irrigation Valves and Valve Boxes
 - v. Pumps and Pump Stations
 - vi. Filtration
- d. Rain Bird products listed in the Landscape Solutions category (as identified on the Rain Bird website referenced above) are excluded from the Golfmax Program Rebate.
 - e. The Golfmax Program rebate will be paid by check directly from NGCOA Canada to the NGCOA Canada Member.
 - f. The NGCOA Canada and the respective NGCOA Canada Member will be responsible for the accuracy of all information submitted and Rain Bird hereby disclaims any and all liability arising from payment of the rebate in accordance with the information provided by NGCOA Canada and NGCOA Canada Member. Any failure by NGCOA Canada and NGCOA Canada Member to provide true and accurate claim information will constitute a breach of the Terms and Conditions of the Golfmax Rebate Program and will result in a forfeiture of the rebate claim.
 - g. The NGCOA Canada and NGCOA Canada Member will cooperate with Rain Bird in processing rebate claims and will supply contact information for the NGCOA Canada Member golf course entity from which the rebate is claimed and upon the reasonable request of Rain Bird.
 - h. Rain Bird will confirm the applicable quantities and materials approved for the rebate, based on the rebate claim, and approve a rebate based on a reasonable purchase price as determined by Rain Bird. In no event will Rain Bird be obligated to make payment to NGCOA Canada for a rebate to a NGCOA Canada Member with respect to any Rain Bird Golf Product in an amount that exceeds the product of: (a) 1.5%, multiplied by (b) the MSRP (manufacturer's suggested retail price) for such product, as listed in Rain Bird's current 2023 US Price List (or 2024 US List Price), or Rain Bird pump station quotation.
 - i. Rain Bird reserves the right to audit and verify all supporting material, including copies of invoices for Rain Bird purchases that are used to justify rebate claims, prior to the approval of any rebate claim. Rain Bird reserves the right to withhold payment or deny claims at its sole and absolute discretion.
 - j. If a discrepancy exists between the invoice and the respective requested rebate claim form, notification of the resolution will be provided by Rain Bird within 120 days to the NGCOA Canada so that it may inform the NGCOA Canada Member.
 - k. All NGCOA Canada Member claims for Rain Bird Golf Products must be submitted to the NGCOA Canada for processing within 120 days of the NGCOA Canada Invoice Date and no claims will be accepted or approved
